It is agreed that the Emerald Show Society will not, under any circumstances, be held responsible for any loss or damage to the stock in trade, equipment, stalls, etc. or any part thereof belonging to an exhibitor.
- **SECURITY:** The Emerald Show Society will provide roving security during Monday and Tuesday nights.
- **SET UP & PACK UP:** Set up of sites MUST BE COMPLETED prior to show opening it's gate to the public at 8:30am Tuesday 5<sup>th</sup> June 2018. Displays, stalls and fixtures, MUST NOT BE DISMANTLED nor goods and/or materials REMOVED and the exhibit MUST REMAIN OPEN and TRADING until 8pm Tuesday 5<sup>th</sup> June and 5:00pm Wednesday 6<sup>th</sup> June 2018.
- **UNDER NO CIRCUMSTANCES - DO YOU REMOVE OR DISMANTLE YOUR STAND PRIOR TO THE DESIGNATED 5:00PM (UNLESS PRIOR WRITTEN ARRANGEMENTS WITH SHOW SOCIETY HAVE BEEN MADE). ANY VEHICLE OR TRUCK ARE BANNED FROM MOVING WHILST PUBLIC ARE ON SHOWGROUNDS.**
